

INSTALLATION

A. Instructions

- Fit the appropriate tube clamp around the front strut in the desired location.
 *Note: you may need to remove bolts connecting the top to the front strut to complete this step.
- 2. If a sliding adapter was supplied in your kit, you will need to loosely fasten it to the soundbar, and then to the round tube clamps installed in step 1.
- **3.** Ensure that the sound bar is in the desired location, then tighten all hardware.

B. Wiring

- 1. Carefully remove the Positive (+) then Negative (-) battery wires.
- 2. A. If installing on a gas vehicle, wire the Negative (Black) wire to the Negative (-) battery terminal and the Positive (Red) wire to the Positive (+) battery terminal.
 - **B.** If installing on an electric vehicle, wire the Negative (Black) wire to the Ground on the DC-DC Converter and the Positive (Red) wire to the Positive (+) post on the DC-DC Converter.
- 3. Route the blue Aux wires to a desired location.
- Tie up all excess wires and reinstall the Positive (+) then Negative (-) battery wires.

C. Electric Vehicles

- 1. Switch it into TOW MODE under the seat.
- 2. On the very last step, switch back to RUN MODE.

Note: DC-DC Converter is required on electric vehicles to avoid damage to the accessory and the vehicle.

What Is Not Covered


